

RELEASE AND WAIVER OF LIABILITY AND ASSUMPTION OF RISK

2022 WTT Junior Nationals - Orlando, FL

(For players 18 years of age and older)

In consideration for the opportunity to participate in tennis matches (the "Matches") during the tennis tournament (the "Tournament") hosted by Recreational TeamTennis, Inc. ("RTT"), the undersigned hereby covenants with RTT, WTT, USTA, LNC, USTA National Campus, Wilson and Gatorade, and any of the instructors, guests, staff, volunteers, sponsors, vendors, suppliers or the officers, agents, affiliates, or legal representatives or successors and assigns of any of them (collectively, the "Releasees"), that he/she shall not sue or bring any legal action or proceeding against any of the Releasees or for or on account of any injury, illness, permanent disability, death, and/or exposure to infectious syndromes or diseases (including but not limited to COVID-19) that he/she may sustain by virtue or arising out of his/her participation in the Matches, his/her presence at, or travel to and from, the Tournament site, or participation in any ancillary activities. The undersigned understands that participation in the Matches at the Tournament involves activities that are not under the control of the Releasees. These presents may be pleaded as a complete defense to any action or other proceeding which may be brought, instituted, or taken by the undersigned, his/her heirs or legal representatives against any of the Releasees in breach of this waiver (this "Waiver"), reserving unto the undersigned the right to proceed against any and all other parties which may be involved in such action or proceeding.

The undersigned acknowledges that participation in the Matches, his/her presence at or travel to and from the Tournament site, or participation in any ancillary activities by him/her is without assumption of responsibility or risk of any kind by any of the Releasees and the Releasees do not make any warranties of any kind with respect to the Matches, travel, attendance, activities, or Tournament. The undersigned assumes the risk of all dangerous conditions arising from and inherent in participation in the Matches at the Tournament and waive any and all specific notice of the existence of such conditions.

The undersigned further agrees that in case of any action being brought for or on behalf of him/her on account of any injury, illness, permanent disability, death, and/or exposure to infectious syndromes or diseases (including but not limited to COVID-19) sustained during his/her participation in the Matches and ancillary activities at the Tournament, travel to and from, or presence at the Tournament site, that he/she will be personally responsible to, and agree to repay to, any of the Releasees and hold each of them harmless against any amounts recovered in connection with any action and all related costs incurred by the Releasees.

This Waiver is executed by the undersigned not in satisfaction of any damages sustained nor as compensation for injuries, nor in settlement of any claim or damages. Said opportunity to participate in the Matches and ancillary activities at the Tournament, travel to and from, or presence at the Tournament site is offered as consideration for this covenant and agreements contained herein. It is distinctly understood and agreed that the acceptance of this covenant by the Releasees is not an admission of any liability on any part of the Releasees and that each expressly denies any liability in any manner.

THE UNDERSIGNED HAS CAREFULLY READ THIS DOCUMENT, FULLY UNDERSTANDS ITS TERMS AND INTENDS THIS WAIVER TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY. IN WITNESS WHEREOF, the undersigned has hereunto set his/her signature to the date printed below.
