

**INJURY WAIVER**

**2022 WTT Junior Nationals - Orlando, FL**

For participants under 18 years of age

In consideration for the opportunity of (the "Minor") to participate in tennis matches (the "Matches") during a tennis tournament (the "tournament") hosted by Recreational "TEAMTENNIS"), I as parent or legal guardian of the Minor, do hereby covenant with WTT, USTA, LNC, USTA National Campus, Wilson and Gatorade for the WTT Junior Nationals - Orlando, FL ) (collectively, the "Releassees") that I shall not sue or bring any legal action or proceeding against any of the Releassees or any of the instructors, staff, sponsors, officers, agents, affiliates or legal representatives or successors and assigns of any of them for or on account of any injury, illness, permanent disability, death and/or exposure to infectious syndromes or diseases (including but not limited to COVID-19) that the Minor may sustain by virtue or arising out of the Minor's participation in Matches or presence at any Tournament site, or participation in any ancillary activities. I understand that participation in Matches shall involve activities which are not under the control of the Releassees. These presents may be pleaded as a complete defense to any action or other proceeding which may be brought, instituted, or taken by me, my heirs or legal representatives against any of the Releassees or any of the instructors, staff, sponsors, officers, agents, affiliates or legal representatives of successors and assign of any of them in breach of the Waiver, reserving unto me the right to proceed against any and all other parties which may be involved in such action or proceeding.

The undersigned acknowledges that participation in Matches by the Minor, his/her presence at or travel to and from the Tournament site, or participation in any ancillary activities by him/her is without assumption of responsibility or risk of any kind by any of the Releasees and the Releasees do not make any warranties of any kind with respect to Matches or the Tournament. I assume the risk of all dangerous conditions arising from and inherent in participation of the Minor in Matches and waive any and all specific notice of the existence of such conditions.

I further agree that in case of any action being brought for or on behalf of the Minor on account of any injury or damage sustained during the Minor's participation in Matches that I will be personally responsible to, and agree to repay to, any of the Releasees or any of the instructors, staff, sponsors, officers agents, affiliates or legal representatives or successor and assigns of any of them and hold each of them harmless against any amounts recovered in connection with any such action and all related costs incurred by such Releasees.

This waiver is executed by me not in satisfaction of any damages sustained nor as compensation for injuries, nor in settlement of any claim or damages. Said opportunity for the Minor to participate in Matches and the Tournament is offered as consideration for this covenant and agreements contained herein. It is distinctly understood and agreed that the acceptance of this covenant by the Releasees is not an admission of any liability on any of their parts and that each expressly denies and liability in any manner.

I HAVE CAREFULLY READ THIS DOCUMENT, FULLY UNDERSTAND ITS TERMS AND INTEND THIS DOCUMENT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY. IN WITNESS WHEREOF, I have hereunto set my signature the date printed below.
